Time Flies when you are Having Fun!

Mary Jean Carey, who goes by Jean, has been with the Eventide Community for 40 years as of January 1, 2017. Jean stated that she was brought into the nursing field by her mother who worked for one of the first nursing homes in this area, Claudia's Nursing Home. She remembers her mother telling her that the work is very rewarding and that the individuals they care for need them. She stated that at that moment she asked her husband if he would be ok with her going to work for 4 years while he was driving semi over the road. That time has flown by because those 4 years have turned into 40 in the blink of an eye.

She started her career with us in 1977 as a Nurse's Aide and continued to work in that position for a year and a half. She was no longer physically able to do the work so she transferred to the laundry department and has been there ever since. She stated she has watched many changes take place throughout Eventide and the one that she still remembers is how their staffing numbers have increased to handle more laundry and that they have upgraded from 35 pound machines to 50 pound machines to be able to keep up with the laundry tasks they complete in a day. Jean stated that throughout all of her time here if she could change one thing it would be that she would have kept a notebook to write down all of the things the Residents she interacted with said and did. She stated that each and every Resident is special and important in their own way and they have all had a big impact on her life, which is one reason she has worked here as many years as she has.

In her spare time Jean enjoys going to the casino, doing crosswords, word searches and spending as much time with her family as possible. She has 4 children, 8 grandchildren and 13 great grandchildren that mostly live around the Denison and Vail area.

Jean stated that she has a great bunch of people to work with and they all care deeply about one another. The Residents are always very thankful and although many people may not think her job is very important she knows it is a detrimental part of how Eventide works. Whether she is hanging up that dress or that pair of slacks, she is doing something for the Residents and she hopes they all know how loved they are.

Increasing Security at Eventide

There are many changes occurring in our environment, both within and outside our walls. After a lot of discussion, in an effort to enhance the safety and security for the residents, staff, and visitors, Eventide will have ONE point of entry and exit for visitors into the nursing facility as of January 1, 2017.

The only door to be used by visitors to enter and exit the nursing facility will be Door #4. This door is labeled "4" from the outside, is the door at the end of Traditional Ridge hall near the offices, and the door on the west side

of the building. The other doors to the facility will be used as Emergency Exits only with the exception of one door for staff use only.

With keeping the safety of our residents at the forefront of our mind, we have decided Door #4 is the best door to use for entrance and exit of our building. The world is changing and reducing access would increase security for those in our building. We hope one entrance/exit will limit door alarms sounding in the building and bring a more home like atmosphere.

We realize this may increase visitor walking distance, so we will keep a wheelchair accessible in the Social Services office (Room #31) which is the first room on the left when you enter the building from Door #4.

The wheel chair will be available for those who feel they cannot make the walk to a resident's room. We only ask that you or a staff member return the chair to the Social Service's office.

Scheduled Medicaid Member Mailings for MCO Enrollment

Important mailings are being sent to all Iowa Medicaid members. The mailings identified below will be sent on ten different days over a five-week period. Following this initial mailing, the Annual Enrollment Letters will be ongoing and sent monthly. The mailings identified below will begin arriving in mailboxes in the coming weeks.

Please note that members do NOT need to do anything unless if they wish to switch to another MCO. If a member wishes to switch to another MCO, please contact the Iowa Medicaid Member Services at 1-800-338-8366.

- IA Health Link Annual Enrollment Letter: Members enrolled in the IA Health Link managed care program have an annual enrollment period each year when they may change their Managed Care Organization (MCO) for any reason. The annual enrollment period is based on their initial enrollment in managed care. This mailing began in December of 2016, and will

be ongoing.

- IA Health Link and Dental Wellness Plan Annual Enrollment Letter: Iowa Health and Wellness Plan (IHAWP) members are enrolled in the IA Health Link managed care program and the Dental Wellness Plan. These members have an annual enrollment period each year when they may change their MCO and dental carrier for any reason. The annual enrollment period is based on their initial enrollment in managed care. This mailing began in December of 2016, and will be ongoing.

- Notice of Privacy Practices: Every three years the Department of Human Services (DHS) is required to mail the Notice of Privacy Practices to all Iowa Medicaid beneficiaries. This notice is included in the mailings identified above. All Iowa Medicaid members who are not enrolled in managed care, or are in the hawk-i program, will receive a separate mailing containing the Notice of Privacy Practices. This is a one-time mailing and has begun in December of 2016.

Depression and Winter SADness

Depression in the elderly is a widespread problem according to the National Institution of Health, and is often not recognized and treated. Being a caregiver or family member also can add to feelings of depression. Changes and life events increase the risk of depression or can make an already existing problem worse.

Common precipitating events include:

- ♦ adapting to a move
- ♦ feelings of isolation or loneliness as children move away, and family and friends pass
- ♦ loss of independence
- ♦ multiple illnesses
- ♦ struggles with memory loss and problems thinking clearly

Signs that an older loved one may be depressed include:

- ♦ being more confused or forgetful
- ♦ eating less or more
- ♦ not bathing and poor hygiene, clothes may be dirty and smell of urine
- ♦ not taking care of their home
- ♦ stopping medications or not taking them correctly
- ♦ withdrawing from others, talking less and not answering their phone

Winter SADness, Seasonal Affective Disorder, is a form of depression that cycles with the seasons. It can occur at any time of the year but typically affects most people in the winter, as the weather gets colder and the days get shorter.

The hormonal changes that lead to depressive symptoms are usually caused by a decline in daylight.

Winter induced SAD generally begins with loss of interest, increased or decreased appetite, and an enhanced feeling of lethargy and tiredness. Residents with dementia may exhibit irritability or agitation.

They often aren't able to recognize or communicate feelings of sadness or depression. According to the National Institution of Health SAD is more likely to strike women. The difference between SAD and general depression is that SAD only strikes during certain times of the year.

It is important to discuss any symptoms of depression with a medical professional to be sure a more serious health concern is not being overlooked. Depression and winter SADness can be treated, and symptoms can be alleviated and managed.

Light therapy, vitamins, counselling, and at times medications are very helpful.

Winter Ball for All

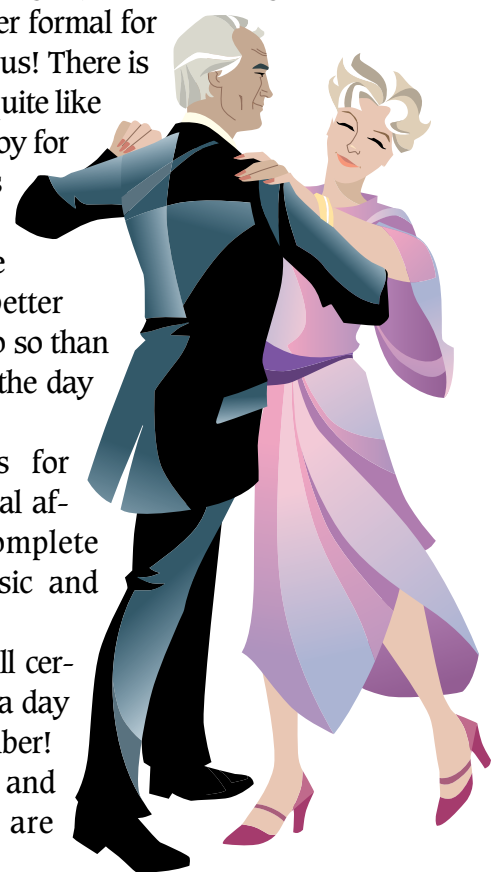
Silveridge is bringing back the magic of dancing to the tenants and residents of the Eventide Community.

Resident Rights and Reminders

PLANNING AND IMPLEMENTING CARE:

§483.10(c) Planning and Implementing Care.

The resident has the right to be informed of, and participate in, his or her treatment, including:

§483.10(c)(1) The right to be fully informed in language that he or she can understand of his or her total health status, including but not limited to, his or her medical condition.

§483.10(c)(6) The right to request, refuse, and/or discontinue treatment, to participate in or refuse to participate in experimental research, and to formulate an advance directive.
