# From the CEO

Eventide has long been known as an area resource and provider in caring for individuals with dementia. We focus on creating awareness about dementia and Alzheimer's Disease because, of those 65 years of age and older, , nearly 62,000 Iowans and nearly 7 million Americans have this diagnosis. According to the Alzheimer's Association, 1 in 9 people aged 65 and older have Alzheimer's. And it's rapidly growing. The Centers for Medicare and Medicaid Services (CMS) project those numbers will climb from 6.7 million to 14 million by the year 2060.

Starting this month, CMS will start a new voluntary nationwide model called Guiding an Improved Dementia Experience ("GUIDE"). GUIDE was developed to support individuals with dementia who do not live in a nursing facility but live in other settings such as their own home or assisted living. The GUIDE model test will launch this month and run for eight years. Per CMS, the model will focus on dementia care management to help improve the quality of life for people living with dementia, reduce strain for unpaid caregivers, and allow people living with dementia to remain in their own homes. Likely behind the implementation from CMS is an innovative way to try to save dollars, especially for Medicare and Medicaid. Per ATI Advisory, 8% of the people with Medicare Fee for Service had a dementia diagnosis in 2023. Experts state the true percentage is likely higher due to those who go undiagnosed, and the costs are skyrocketing. Reportedly, another goal of this program is to get people properly diagnosed and coordinate the needed services.

 Only those on Traditional Medicare – no Advantage/Managed Care Plans – are eligible with a qualifying dementia diagnosis.

• Eligible recipients can expect a letter informing them of the program. Some anticipate this may not be released until January of 2025, however. Please note it is anticipated these letters may also come from approved providers across the nation who may approach delivery of care remotely on a virtual basis.

• Those on the program will have a comprehensive, standardized delivery approach with an interdisciplinary care team as well as a care navigator.

• The individual will be placed in one of five tiers based on assessment. This tier will dictate the monthly payment per beneficiary.

• There will be a respite care payment option currently capped with an annual dollar amount.

• The provider list for GUIDE has not yet been released by CMS but is expected to come out soon (likely July).

Eventide Leadership supports CMS for developing an innovative approach to providing resources to those affected by dementia, and we anticipate this has the ability to change the landscape of caring for those with dementia. We will continue to monitor and engage in the GUIDE program and embrace the model for the future as Eventide looks to be a partner organization with the selected providers. Stay tuned.





# When is the right time? | Long-Term Care Insur-

I often get phone calls from family members stating, "I'm not sure if it is the right time, but I think nursing home placement is coming for my loved one." It is often followed by statements of guilt and questioning if it is the right thing to do. The most disheartening thing I hear is, "what will people think of me if I am no longer able to care for them?" I am here to tell you there is no perfect time. These are hard choices and decisions that no one can ever really prepare for. Caregiving is not an easy task. Just when you think you have got the hang of it, a wrench gets thrown into your plans! Here are some common things I tell caregivers when I get these calls. We are all aware of the safety briefing on an airplane and understand the importance of putting our own oxygen mask on first before helping others. The same applies to caregiving. If you cannot take care of yourself anymore it is nearly impossible to effectively care for someone else. Sometimes it is okay to stop and acknowledge all the hard work you have done thus far, as well as remember you are doing the best you can. You can only help so much though, and you are not in control of your loved one's total health. Just try your best to handle the events that are in your control. It never hurts to do your research early in the process to see what resources are available in your area. Sometimes touring different facilities helps you break the stereotypes you have about senior living. Placing your loved one in a community does not mean you are done being the caregiver. Your role is still a very important part of their care team when they live in a nursing facility. Although you might not be doing the hands-on work of caregiving anymore, you can still be an advocate for them and a friend. Please know there are several levels of care within the Eventide Campus. We have independent living, assisted living, skilled care, nursing home care, memory care and hospice care. # **Resident Rights**

- Self-Determination (cont): The resident has the right to and the facility must promote and facilitate resident self-determination through support of resident choice, including but not limited to:
- a. The resident has the right to manage his or her financial affairs. This includes the right to know, in advance, what charges a facility may impose against a resident's personal funds.
- i. The facility must not require residents to deposit their personal funds with the facility. If a resident choose to deposit personal funds with the facility, upon written authorizations of a resident, the facility must act as a fiduciary of the resident's funds and hold, safeguard, manage, and account for the personal funds of the resident deposited with the facility, as specified in this section.
- ii. Deposit of Funds. (A) In general: the facility must deposit any resident's personal funds in excess of \$100 in an interestbearing account (or accounts) that is separate from any of the facility's operating accounts, and that credits all interest earned on resident's funds to that account. (in pooled accounts, there must be a separate accounting for each resident's share) The facility must maintain a resident's personal funds that do not exceed \$100 in a non-interest bearing account, interest-bearing account, or petty cash funds. (B) Residents whose care is funding by Medicaid: The facility must deposit the residents' personal funds in excess of \$50 in an interest-bearing account (or accounts) that is separate from any of the facility's operating accounts, and that credits all interest earned on separate account for each resident's share. The facility must maintain person funds that do not exceed \$50 in a non-interest bearing account, interest-bearing account or petty cash fund.
