The senior living industry has seen many challenges in the last few years, and it is not stopping anytime soon. This industry will continue to face significant transformation in the coming years too while being driven by demographic shifts, technological advancements, and evolving care models. The Eventide campus has focused heavily on updating our Strategic Plan as the population ages, the prevalence of chronic conditions rises, and demand for long-term care services grows. With the above, this is a great time to reflect the amazing pride within the Eventide Campus in being a local nonprofit organization which is truly making a difference with those we serve and those on our team. At a time when many mergers and acquisitions occur in nearly every industry, ours is no different. Across the United States and in Iowa, we are seeing a growing number of private equity firms investing in senior living organizations. With the ongoing debate of private equity ownership and quality of care in senior living facilities, these transactions are certainly something to monitor for the impact on residents and overall healthcare system. Policymakers and regulators are paying more attention to the role of private equity firms in senior care to ensure the drive for profits does not compromise the quality of care provided to residents.

# Stay Safe and Warm This Winter

As we age, it often feels like we are always cold. The natural changes that come with aging can make it harder for older adults to recognize when their bodies are becoming too cold, which can quickly turn into a serious health concern.

Did you know that certain medical conditions can impact our ability to regulate body temperature? For instance, people with diabetes may experience changes in blood flow that prevent the body from generating warmth effectively. Thyroid problems can also interfere with the body's ability to maintain a stable temperature. Additionally, conditions like Parkinson's disease and arthritis can make it difficult to perform activities that help with warmth, such as adding layers of clothing, using blankets, or quickly moving in and out of the house. Some medications can affect body temperature as well. If you are concerned, it is always a good idea to speak with your doctor to determine whether your medications could be influencing your body temperature, and if there are adjustments you can make to help.

During the winter months, it is essential to reduce the risk of falls, especially in icy conditions. On days when the weather is particularly

dangerous, it's best to stay indoors. If you need to go outside, consider asking family or friends to help with salting or sanding your walkways. Hiring a snow removal service can also help keep driveways and sidewalks clear. And remember, do not attempt to shovel snow by yourself—it can be both physically taxing and dangerous for older adults, with an increased risk of heart attacks. It is perfectly okay to ask for help!

To ensure your safety when walking outside, consider installing railings along your outdoor paths to provide extra stability. Also, be sure to wear non-skid, rubber-soled shoes with low heels to prevent slipping.

Take advantage of services like grocery delivery, prescription delivery, and meal delivery to reduce the need to venture out in bad weather. Many communities offer these programs, so do not hesitate to call and inquire about what might be available in your area.

By staying aware of these risks and taking the necessary precautions, you can enjoy the winter season while minimizing potential hazards to your health and safety.

# **Over-The-Counter Medications Can Impact More** Than Just the Common Cold

As an RN, one of the things I am passionate about is education and awareness. I have spent countless hours in continuing education trying to better myself as a nurse and as an advocate for seniors. Throughout this education I have grown an interest in a particular topic which I wanted to share with you with the hopes it will create awareness and encourage a conversation with your health care provider. I have learned a great deal about a certain kind of over-the-counter medication and how it could potentially impact memory. Considering dementia and memory loss continue to be an ongoing concern among our aging population, we all need to be proactive about ensuring we are doing what we can to decrease our likelihood of developing dementia and other memory issues.

Healthy brains naturally produce the amino acid Acetylcholine, or ACh. The body produces ACh from acetyl coenzyme A and choline, which are found in foods like egg yolks, legumes, and seeds. The role of this compound is to function as a neurotransmitter in the brain. Neurotransmitters send messages from one neuron to another within the nervous system. ACh plays a key role in many bodily functions such as muscle movements, breathing, and our body's immune response. One of the key roles of ACh is in also brain function...it is vital to memory and learning.

Studies have shown there is a direct correlation between low levels of ACh and memory loss. There are, of course, many instances of memory loss which are attributed to uncontrollable situations. Memory loss or confusion may have been onset by things such as brain injuries, mental health conditions, disease processes, etc. ACh also naturally decreases in the brain as we age, which cannot necessarily be helped. There is, however, one factor in memory loss that we may be able to better control... what we put into our bodies that directly affects ACh.

There are certain medications that have a direct impact on the ACh in our brains. One of these classes of medications is called anticholinergics. These medications block the action of acetylcholine in the brain and body. Now... there are many benefits to prescription anticholinergic medications such as treating asthma, COPD, nausea, motion sickness, overactive bladder, regulating heart rhythm, etc. They also can help block involuntary muscle movements associated with certain

diseases such as Parkinson's Disease. In these situations, your medical provider likely finds the benefits of these medications far supersede the adverse actions of the medication.

There are, however, many over- the-counter anticholinergic medications that affect ACh in the brain and people likely do not even realize it. These medications can cause confusion, memory loss and worsening mental function especially in people over the age of 65 years. Medications such as Benadryl, Dramamine, Imodium, Dimetapp, NyQuil, Unisom, and mostly all medications with the word 'PM' (Tylenol PM, Advil PM, etc.) contain diphenhydramine, which is an antihistamine that causes drowsiness... well guess what... diphenhydramine also blocks ACh in the brain. These medications, while easily accessible and often heavily used for long-term symptom management, have been linked to increasing risks for dementia.

Now this information is for general informational purposes only and is not to be used as medical advice. Do not disregard medical advice from your provider. I am not saying in the event someone has an allergic reaction they should avoid taking Benadryl if that is what their health care provider has instructed. Individuals should follow their medical provider's recommendations. What I am suggesting though is to ensure that your medical provider is aware of ALL medications you might be taking, even if you think they are insignificant. I personally know an individual who has been taking Tylenol PM for years to help them sleep. I also know another individual who likes to rely on NyQuil as a sleep aid a few times a week. When I mentioned how these medications could potentially impact memory on these individuals as they age, they both seemed completely unaware that over-the-counter medications could cause issues such as memory loss. After all, they are on the shelves and easily accessible.

By speaking with your provider about your over-the-counter medication use they will be able to assess your concerns and need for the medications. They also will be able to inform you of any better alternatives such as melatonin if you have been relying on Tylenol PM to help you sleep. Over-the-counter medications, while easily accessible, have their fair share of adverse effects and concerns with chronic use. Please take the time to review any and ALL medications and supplements routinely with your medical provider as they can impact far more than you realize.
